



**2020 Speed & Feed BBQ Festival & Cruise-In
March 13-14, 2020 In Darlington, SC**

Darlington Raceway is currently accepting applications to the 2020 Speed & Feed BBQ Festival & Cruise-In from March 13-14, 2020. To ensure success of vendors and attendees, care is taken to offer a variety of activities, shopping, and entertainment.

Rules and Regulations:

- Darlington Raceway reserves the sole right to select any and all participants. Applicants will be approved based on product duplication and spirit of cooperation.
- Applicants will be processed in the order of date received and must include all fees, pictures, and other information that may be required in order for the application to be considered.
- Non-Food/Beverage Vendor spaces are \$50.00 each.
- Deadline for vendor applications is Friday, March 1, 2020.
- Vendors may set up Friday, March 13th between 12:00 pm and 4:00 pm and remain set up through the conclusion of the event that next day (approximately 5:00 pm on Saturday).
- Vendors must provide their own tents, tables, and equipment.
- Booth spaces will measure 15' x 15'.
- Vendor will be solely responsible for the security and safety of vendor's cash, coupons, equipment, goods, inventory, supplies, or other property.
- No electrical power will be provided to the vendors.
- Vendors cannot stake equipment into the ground, the event is on asphalt but all equipment should be secured (i.e. sandbags/weights).
- Vendor must occupy the space assigned. No subletting of space will be allowed.
- NO political handbills, flyers, posters, banners, stickers, or other literature will be allowed within assigned area.
- Darlington Raceway has the right to remove vendors and employees who violate these rules. If a vendor is removed from the Speed & Feed BBQ Festival & Cruise-In, no refund will be issued.
- No rain date is scheduled for the festival. No refunds can be issued if Speed & Feed BBQ Festival & Cruise-In is canceled or delayed due to inclement weather.
- Vendor must provide Darlington Raceway a copy of their certificate of insurance if they have insurance. If you don't have insurance you can purchase through the Event at a cost of \$65.00.

Such policy shall name as additional insured Darlington Raceway of South Carolina, LLC, its parent company, their subsidiaries, limited liability and affiliated companies and their respective shareholders, members, officers, directors, agents, employees, trustees, receivers, successors and assigns. Such insurance shall be primary and non-contributory to any other insurance available to the additional insured parties.

**Insurance may be purchased through the Event at the cost of \$65.00. Insurance secured through the event must be purchased by Thursday, March 5th, 2020.*
