Enclosed in this document are vendor requirements and an application for participation for the 2020 Speed & Feed BBQ Festival & Cruise-In. Darlington Raceway of South Carolina, LLC will issue acceptance or decline emails based on the information submitted. Applications must be submitted via email or mail and applications that are incomplete will not be considered. In making sure we obtain quality vendors for our festival, we ask that you include a list of festivals you participate in within a calendar year so we make reference contacts.

A limited number of each type of vendor will be accepted to each event to cut down on competing vendors. Vendors will be selected based on several items, including experience, festival references, items and equipment. Vendors are expected to comply with all rules and regulations of the Darlington Raceway, Darlington Police Department, Darlington Fire Department, South Carolina Department of Health and Environmental Control and other governing authorities' rules and regulations that might apply.

Vendors are responsible for collecting an 8% South Carolina sales tax and are responsible for all licenses applicable required by the City of Darlington and the State of South Carolina.

INSURANCE: Upon execution of this Agreement, but in no event less than 7 days prior to the first scheduled day of the Event, Vendor agrees to secure and maintain with a reputable company:

A. **Commercial General Liability Coverage:** Vendor shall secure and maintain throughout the Term, commercial general liability policy (including personal injury and contractual liability) with a combined single limit of not less than \$1,000,000 per occurrence; \$2,000,000 aggregate. Such policy shall name as additional insureds Darlington Raceway of South Carolina, LLC, its parents, their subsidiaries, limited liability and affiliated companies and their respective shareholders, members, officers, directors, agents, employees, trustees, receivers, successors and assigns (the "Indemnified Parties").

B. **Automobile Coverage:** Vendor shall secure and maintain throughout the Term motor vehicle (including hired, owned, and non-owned) liability insurance on any vehicle to be used at or in connection with the performance of this Agreement, with coverage limits of not less than \$1,000,000 per occurrence.

When filling out the application, please indicate if you need additional footage or electricity for the event. Also, please keep in mind the following:

- There will be no shade/sun protection but you may bring your own tent. However, there is **NO staking** allowed in the paved areas.
- Vendors must provide tables, chairs, tents, extension cords, hand trucks and any other items required to do business during the event.
- Ice will be available at the event. Cash only.
- Electricity will be confirmed the day of the event by an amp meter and festival organizer. Additional electricity will not be available for purchase at the event.
- Vendors must discard of their own trash during and after the event. Failure to comply will result in exclusion from future events.
- Please keep in mind what is stated when filling out your application.

Vendor Rules

General Rules:

- Vendors must have wheels and be mobile (i.e. truck, trailer or food cart).
- The Entry Fee of \$400.00
 - The Food Truck Rodeo is an outdoor event and is held rain or shine. The entry fee is non-refundable.
- No food and/or beverage sales are allowed without a valid permit. You must have a copy of the permit with you during the Food Truck Rodeo.
- Vendors must comply with all laws, ordinances, and regulations of the United States, State of South Carolina, Darlington County, and City of Darlington, including health laws and regulations, including but not limited to special events.
- All prepared food items, meat, fish, and cheese sold must meet state and local health regulations including the inspection of the prepared foods seller's kitchen by SCDHECA health inspectors, and labeling in compliance with the regulations. Sellers must have a copy of their inspection form with them when selling at the Food Truck Rodeo.
- Vendors must complete a post-event report at the conclusion of the event.
- Display/Set-up:
 - One truck/vendor space is approximately 10' x 20' for one food truck.
 - Set-up time is March 13th 8:00 am to 3:30 pm. Vendors must be ready when the gates open and stay until the event closes each day.
 - The 2020 Speed & Feed BBQ Festival staff or designee will assign vendor space.
 - Upon arrival, vendors should check in with the 2020 Speed & Feed BBQ Festival staff at the entrance gate for directions on where to set up.
 - Vendors must provide their own tables, displays, canopies, tents, etc.
